4. Reading of July 19, 2018 Board Meeting Minutes

Ms. Hume made a motion to accept the minutes as printed. Ms. Rottier seconded the motion. Motion carried.

5. Treasure's Report for July 19, 2018

Mr. Studer suggest changing the 3100 to 3101 on the budget to match the profit and loss report.

Mr. Studer states service income is 10.34%, interest income is 0.03%, taxes is 1.04%, gross profit is 5.95%, payroll expense is 6.69%, and operations is 12.36% because of the onetime payment for liability insurance. Mr. Studer reminds the board that \$80K for engineering was approved in last fiscal budget and out of that \$80K FLDWID has spent \$23K towards engineering for the Main Trunk Line Upgrade. Ms. Rottier made a notion to accept the treasures report as presented. Ms. Hume seconded the motion. Motion carried.

Mr. Cooper reports delinquents is \$428.69 with no customer issues. Email billing is 187 customers. Ms. Belch will send out an email blast and also add a note to the customer's bills next month for email billing.

Mr. Cooper and Ms. Belch completed the internal audit finding 4 items that were corrected immediately.

Ms. Irwin is working to complete the financials for 2017-2018 fiscal year.

Mr. Cooper, Mr. Morehead, and Rim Country Tile and Stone have completed the office bathroom.

Mr. Cooper has provided a time line for the board members on the main trunk line project. Mr. Cooper spoke with Mr. Brimhall about the expectations of Coconino County regarding the main trunk line. Mr. Brimhall will contact Mr. Cooper when he has a time, date, and location for a meeting with Coconino County. Mr. Cooper will present the last 3 upgrades in Forest Lakes Estates, pictures of electric poles where the county wants the water lines to be installed, and show no maintenance issues on the water lines installed in the past.

Mr. Cooper will contact Mr. Jim Parks if necessary and even the lawyer if need be.

Mr. Cooper reports water pumped 6,803,559, customer metered 6,619,062, storage 55,000, and unaccountable water is 129,497.
