4. Reading of July 2019 Board Meeting Minutes, August 2019 Special Board Meeting Minutes and August 2019 Open Meeting Minutes

Ms. Hume made a motion to accept the minutes as printed. Mr. Grimmett seconded the motion. Motion carried.

5. Treasure's Report for Preliminary July 2019 Profit and Loss and Bank Balance

Mr. Studer reports this is a preliminary report. The service income is 12.29%, total income is 7.15%, payroll expense is 7.97%, operations is 11.87%, and capital outlay is 12.6%. Credit card rewards total is \$1476.39. Mr. Studer explained the construction time line as it refers to payments. Material paid in full at \$226,435.59 a savings of \$10,331.47. Contactors paid to date \$335,001.58 with a balance of \$276,213.55 excluding the buffer of \$20,000, contingency of \$25,000, and rock excavation of \$77,100.00. Painted sky engineering balance is \$25,000. The document will be ongoing until project is complete. Bank balance between all three accounts is \$696,273.41. Ms. Hume made a motion to accept the treasure's report as presented. Ms. Rottier seconded the motion. Motion carried.

6. On-Site Manager's Report for August 2019

Mr. Cooper reports 891 customers, delinquents are at \$326.28 with no customer issues. Email billing has 229 customers. Internal audit findings were nonstandard bonus invoice not filed in personal files and a copper point invoice miss filed. Ms. Irwin should have closing financials prior to next board meeting.

Meeting with Mr. Brimhall from Painted Sky Engineering and Mr. Teryl from Western Grade on July 24. Mr. Teryl is bringing in another crew. Crews are now working 10 hour days 5 days a week. As of July 31 construction was at Wildcat and Baily Dr. Construction is 3 weeks behind.

Pumped water was 9,264,005, customer's used 8,723,385, leaks 200,000, Forest Service 30,000, construction 50,000, and unaccountable 260,620.

Discussion and Possible Decision on the Dollar Amount to Cover the Cost of the Little Colorado River Coalition Fee

Mr. Studer made a motion to add \$3.74 to each customer's bill starting with September's billing with a note attached to the billing stating 891 customers, times 3.74 dollars, times 12 months, totaling \$39,998.08 to cover the Little Colorado Coalition Fee. Ms. Hume seconded the motion. Mr. Grimmett asked if anyone objected to the \$3.74. Mr. St. Germain stated he liked \$3.71. Mr. Grimmett stated he would go along with Mr. Studer at \$3.74. Ms. Hume stated \$3.74. Motion carried with Ms. Hume, Mr. Studer, and Ms. Rottier as yay votes, Mr. Grimmett as a nay vote, and no vote needed from Mr. St. Germain.
