8. Treasure's Report for December 2018

Mr. Studer reports service income is 52.59%, interest income 208.47%, taxes is 62.64%, Miscellaneous is 123.74%, payroll 45.04% operations, 49.32%, travel is 43.35%, and Capital outlay is 1.22%. Bank accounts total \$ 985,539.50. Ms. Rottier made a motion to accept the treasures report. Mr. Grimmett seconded the motion.

9. On-Site Manager's Report for December 2019

Mr. Cooper reports 891 customers with \$ 517.38 in delinquents. 2016 customers have signed up for email billing. FLDWID has \$344.75 in credit card rewards. Ms. Belch spoke with Mr. Brown from Brown and Brown Law and he will get back Ms. Belch after he speaks to his constituents in January 2019. Mr. Cooper reminds the board members that Monday January 21 is the last day for the RWAA conference, so please see Ms. Belch and she will sign you up.

Mr. Cooper reports Mr. Brimhall is having trouble obtaining proper documentation of the easements without opening any new questions. Mr. Brimhall and his assistant will continue to work on this. Mr. Brimhall sent over an email stating Coconino County wants the water line for the main line project to be 2-3 feet off the edge of the road. Mr. Cooper reports FLDWID has approval from ADEQ for construction and permits from Coconino County. FLDWID has spent \$4005.37 this fiscal year on engineering and permits for construction of the main trunk line. Ms. Belch will add the construction time line to the bills to notify customers.

Mr. Cooper reports water pumped was 742,852, customer's used 686,756, and unaccountable water totaled 56,096 making the average for the fiscal year 3.88%.
