Mr. Cooper reports delinquents is up to \$482.77 with no customer issues and email billing remains at 185 customers. IRS did a field visit looking for 941 tax filing from 2015, Ms. Belch was able to assist him by finding the document. Reward points from National Bank of Arizona is \$1427.10 and those have been transferred to the bank account.
