Ms. Robinson added 3 more customers to the email billing. Ms. Belch closed the financials in the office. Prepared all documents for Ms. Irwin, CPA. The next stop is to scan all documents for the fiscal year 2023-2024.

Pumped water totaled 7,569,456, customers used 6,797,565, Pima paving used 23,822, Coconino County used 217,495, FLDWID used 100,000, and unaccountable is 430,574. Giving FLDWID a 6.34% for fiscal year.



Mr. Gary Richardson closed the Board Meeting at 12:18 pm.


