1. Discussion and Review of the Security for Forest Lakes DWID's Water

Mr. Studer recommends adding an automatic gate to the entrance of the water districts yard.

Also and adding also to page 20, section 8, rates, user fees and miscellaneous charges. Mr. St. Germain joined the meeting.
